- 1. In connection with your attendance at a meeting of the District Presbytery, the Disclosing Party is requiring all attendees at the meeting District Presbytery, scheduled for May 9, 2023, to confirm that the meeting contents and handouts (hereinafter "Confidential Information") will remain confidential and used solely for Disclosing Party's benefit.
- 2. This Agreement is solely intended to set forth the terms and conditions upon which the Recipient Party is allowed to receive Confidential Information for use during the District Presbytery meeting. The Recipient Party may not use the Confidential Information outside of an officially called District Presbytery meeting for any purpose except as described in Paragraphs 3 and 4 below. The Recipient Party agrees to turn off and store their cell phone during the meeting as a condition of participating in the meeting.
- 3. In consideration for the disclosures referred to in Paragraph 1 hereof, the Recipient Party agrees to hold the Confidential Information in strict confidence and not to disclose any part of the Confidential Information to any person without the written consent of the Disclosing Party. The Recipient Party further agrees that he will not, without the Disclosing Party's prior written consent: (i) use the Confidential Information other than for the purpose of fulfilling his tasks and responsibilities owed to the Disclosing Party; or (ii) disclose all or any part of the Confidential Information to any person other than those designated in writing by the District Presbytery. The Recipient Party further agrees to return all documents to the Secretary at the end of the meeting. This prior sentence is intended to cover any notes or minutes Recipient Party creates from this District Presbytery meeting.
- 4. The Recipient Party shall be entitled to disclose the Confidential Information to the extent required by any applicable law, order, decree, regulation, or rule; provided, however, when reasonable, the Recipient Party shall notify the Disclosing Party of any demand for the production of such Confidential Information. If necessary, the Recipient Party will only furnish to third parties that portion of the Confidential Information which the Recipient Party is legally required to produce.
- 5. The term of this Agreement shall be ten years from the date of its full execution by the parties. It shall be governed by and construed in accordance with the laws of the State of Texas.
